33 Unanswered Questions About Pres. Kennedy's Death

As the investigation of the President Kennedy's assassination and the murder of his presumed assassin goes on in Dallas, many questions crowd the anxious minds of U.S. citizens.

Several sources, including a New York Times Columnist, have suggested a national commission of inquiry similar to the blue ribbon Pearl Harbor investigation. Such an investigative group would be non-partisan and might well include both former Presidents, Dwight D. Eisenhower and Harry S. Truman, if their health permits.

The Chicago Daily Defenderbelieves that the circumstances of the Dallas tragedy should be fully explored and the nation informed.

Our own staff and a number of citizens asked the following questions:

1. Why was not Lee Harvey Oswald's stomach pumped Friday afternoon to establish conclusively whether he had or had not consumed the halfeaten chicken found in the Texas Book Depository building?

2. If this the assassination of Kennedy is the spur-of-the moment, emotional crime of a fanatic, why did Oswald use an assumed name in March when he allegedly purchased the gun by mail from a Chicago gun house?

3. Was Oswald ever in Jack Ruby's night clubs spots? This was alleged from first reports by both an ex-Dallas stripper and a waiter. The stripper was later written off as a publicity hound. Was the waiter a

valid witness?

4. At least one national television network announced -Sunday evening that the Dallas police reported that there was a connection between Oswald and Ruby and that the latter had killed Oswald "to shut him up." Was this report completely inaccurate?

Did the FBI have Oswald. the known Marxist with a Russian wife, under surveillance since his return from Russia? If not, why not?

6. There is confusion about a report that the FBI or Secret Service had questioned Oswald as a normal precaution before the Kennedy tour. What is the truth? If the FBI did question nim. (a. Chicago paper reports flatly the FBI had) why was not the Dallas Police force informed of his presence town? 7. Swatikas were painted on

Jewish business houses in Dallas in April; the incident involving Ambassador Stevenson occurred several weeks ago. There have also been news reports that both Stevenson and Gov. John Connally warned Kennedy of danger in Dallas. Friday morning the Dallas Morning News published a full page hate ad paid for by right wingers. In light of all this, why was the President's route through Dallas not changed? If he insisted, as reported, on the route used, why did not the security forces take extra precautions to guard him from a sniper? Why was the bubbletop not used? Why were Secret Service men not on the fenders and back of the car to shield him?

8. Why, if at least one unarmed private citizen saw a
